8	Thomas Gilliland (Gilliland) and the Oregon Board of Chiropractic Examiners (Board)
9	stipulate and agree that Gilliland is a licensed chiropractic physician subject to the jurisdiction
10	of the Board, which is the state agency responsible for licensing and regulating chiropractic.
11	2.
12	Specifically, Gilliland agrees that between April 6, 1992 and April 15, 1992, Gilliland
13	treated patient for neck, should and low back pain. During the treatment,
4	Gilliland also tested for allergies, utilizing a device know as the "Interro" for
5	the diagnosis. As a result of the diagnosis, Gilliland prescribed a homeopathic remedy for
6	
7	3.
8	Gilliland agrees that between March 23, 1992 and April 19, 1993, he allowed
9	to advertise as a "licensed physiotherapist" on business cards which
0	represented not only but also the Southside Chiropractic Clinic and Thomas Gilliland,
1	D.C is not currently, nor has he ever been licensed as a physiotherapist.
2	4.
3	The following sanctions may be imposed against Dr. Gilliland:
4	A. A civil penalty in the amount of \$1,000 for dispensing homeopathic remedies in
5	violation of ORS 684.015(3).

1	B. A civil penalty in the amount of \$500 for violating ORS 684.100(1)(a), by using
2	business cards misrepresenting the credentials of , a Chiropractic
3	Ancillary Personnel.
4	5.
5	Gilliland agrees to make payments to the Oregon Board of Chiropractic Examiners, a
6	796 Winter Street, NE, Salem, OR 97310, in the amount of \$250 per month for 6 months.
7	Payment must be received between the first and fifth day of each calendar month. The first
8	payment is due April 1, 1994. If payments are not made according to the terms of this
9	stipulation, the Board may discipline Gilliland.
