

1 Licensee and the date was extended to August 6, 1999 for all records to be provided. Licensee
2 failed to respond to the letter of July 26, 1999.

3 3.

4 On July 29, 1999 Licensee telephoned the Board investigator and indicated he would
5 forward copies of the patient files with his explanations to the Board as soon as he could. To date,
6 no response or records have been received by the Board or it's investigator. To date, the only
7 contact the Board has had with Licensee was his telephone contact on July 29, 1999. Licensee has
8 made no further efforts to cooperate with the investigation or provide the records requested.

9 4.

10 Between June and August of 1999, numerous telephone messages have been left by the
11 Board investigator at Licensee's place of business. All contacts have gone unanswered.

12 5.

13 On September 25, 1999 the Board voted to issued a notice of proposed disciplinary action
14 which was sent to Licensee on October 12, 1999 to Rogue River Chiropractic, P.O. Box 1107,
15 Rogue River, Oregon by certified mail giving him twenty-one days in which to answer the notice.
16 The certified mail was picked up and acknowledged on October 14, 1999. Subsequently, on
17 November 2, 1999, the Board's investigator placed a call to Dr. Kellim's office to inquire about
18 the Licensee's response and spoke with Susan, who said she would relay the request for Dr. Kellim
19 to call the Board office. No call was ever received. No answer to the notice was not received as of
20 November 4, 1999, twenty-one days from October 14, 1999. Nor has any answer been received as
21 of the date of this Final Order by Default.

24 The Board finds that the acts and conduct of Licensee described constitutes a failure to
25 cooperate with an investigation by the Board and the above acts are in violation of ORS 684.112
26 (failure to provide requested records); and OAR 811-035-0015 (19) and (20).
