WHEREAS, there is presently pending before the Oregon Board of 7 Chiropractic Examiners an administrative proceeding initiated by the service upon Michael Kirkland, D.C. of a Notice of Proposed Revocation of Chiropractic License, and, WHEREAS, this Notice of Proposed Revocation of Chiropractic 11 12 License indicated a proposal, on the part of the Oregon Board of Chiropractic Examiners, to revoke Dr. Kirkland's chiropractic license 14 because of his conviction in April of 1989, in the Circuit Court of Polk County, State of Oregon, of a crime involving moral turpitude, that is to say the crime of submitting a wrongful claim, and, WHEREAS, because of the circumstances surrounding this 18 conviction and the treatment accorded Dr. Kirkland by the prosecutor and the sentencing court, the Oregon Board of Chiropractic Examiners is willing to impose a penalty less serious than a license 21 revocation or a suspension, and, WHEREAS, Michael Kirkland, D.C. is willing to agree that the 23 Oregon Board of Chiropractic Examiners may enter a final order which 24 contains the following provisions and the Oregon Board of Chiropractic Examiners is willing to dispose of this matter based .6 upon the entry of such final order,
