14 The Board of Chiropractic Examiners (Board) is the state agency responsible for
15 licensing, regulating and disciplining chiropractic physicians in the State of Oregon. Bryan Scott,
16 D.C. (Licensee), is licensed by the Board to practice as a chiropractic physician in the State of
17 Oregon. The Board proposes to discipline Licensee for the following reasons.
18

19 1.

20 On March 26, 1999, Licensee signed a Stipulated Final Order in case number 98-1014.
21 That order required in paragraph 9 of License Limitations:

23 Licensee is assessed the costs of this proceeding in the amount of \$1,305.40 pursuant to
24 ORS 684.100(9)(g).

26 2.

27 During October 2002, Licensee made a \$100 payment toward that amount owed. License
28 has made two \$100 payments in August and September 2005. Since that time, Licensee has
29 failed to make any further payments, nor make arrangements with Board staff to make future
30 payments.

32 3.

33 Between October 2002 and May 2005, several letters and telephone calls were made by
34 Board staff in attempts to get Licensee to make payments on the amounts due. During May,
35 2005, Board staff contacted Licensee again reminding him of his obligation and that he was in
36 arrears on the final order. Licensee indicated he would begin making monthly payments.
37 Licensee has failed to make any further payments beyond the only payment in October 2002.
38 Licensee has made two \$100 payments in August and September 2005.

40 4.

41 The Board finds that Licensee's failure to make payments as agreed in his Stipulated
42 Final Order is a violation of ORS 684.100 (1)(g); OAR 811-035-0015(23).

5.

On July 26, 2005, the OBCE proposed to indefinitely suspend the licensee of Licensee due to the aforementioned violations until full and final payment has been received. Licensee has responded that his economic circumstances prevent him from doing so. Licensee did not request a contested case hearing.

Stipulations

This matter having come properly before and been considered by the Board, and Licensee having voluntarily stipulated and consented to the issuance and entry of this order by signing below,

IT IS HEREBY ORDERED THAT:

1. Licensee agrees to make monthly payments of \$100, due and payable by the 1st of every month, until the remaining amount owed of \$1005 is paid.
2. If ten days pass the 1st of the month, and payment is not received, Licensee agrees that his chiropractic license will be automatically suspended until that months payment is received.

Effective upon the signing of both parties.
