Specifically, Berardi was alleged 14 to have provided excessive and unnecessary treatment while 15 maintaining incomplete records, or failed to obtain consultations 16 or perform referrals consistent with standards of care of the 17 profession. 18 2. 19 Berardi and the Board agreed to enter into the following 20 Stipulation for the purpose of concluding the contested case 21 proceeding initiated by the Board's Notice of Proposed Sanctions: 22 The Board has jurisdiction over the matters alleged in 23 the Notice of Proposed Sanctions. 24 b.
