15	The Oregon Board of Chiropractic Examiners (hereafter "Board" or "OBCE") is the state
16	agency responsible for licensing, regulating and disciplining chiropractic physicians and certified
17	chiropractic assistants in the State of Oregon. Cynthia M. Colwell DC (hereafter "Licensee"),
18	is a licensed Chiropractic physician in Oregon.
19	
20	Findings of Fact
21	
22	1.
23	Licensee renewed her license May 27, 2011 and signed the affidavit stating, "I swear and
24	affirm that I have completed all of my required continuing education credit hours by my license
25	renewal date 5/31/11."
26	
27	On Oct 24, 2011, the Board mailed a CE Audit request to Licensee to her address of
28	record. Licensee has a renewal date of May 31, 2011. On November 22, 2011, the Board sent a
29	last minute reminder to Licensee requesting her response. On November 18, 2011 and
30	November 29, 2011 Licensee faxed letters requesting a hardship waiver and stated she had
31	financial and medical difficulties. Licensee stated she had not completed the required CE.
32	
33	2.
34	The OBCE reviewed Licensee's lack of response on Dec 1, 2011 and voted to issue a
35	Notice of Proposed Civil Penalty. They also determined that she had not made her request for a
36	hardship waiver in a timely manner.
37	
38	3.
39	A Notice of Proposed Civil Penalty was issued on December 19, 2011. Licensee's
40	response was received January 19, 2012 which also provided evidence of completion of the 20
41	hours CE taken between January 8 and 15, 2012. She also sent a \$250 payment towards the civil
42	penalty. Licensee did not request a hearing.

2 3 4 5 6	4. The Board finds that Licensee's failure to complete the CE within the time period required is a violation of OAR 811-15-0025 and ORS 684.092. In signing the renewal affidavit stating the CE was completed within that time period, when it was not, Licensee violated OAR
7	811-035-0015(16).

12	Licensee is assessed a \$250 civil penalty (which has been paid). The remaining proposed
13 14	\$1,000 civil penalty is waived.
