Steven Ellsworth (Ellsworth) and the Oregon Board of Chiropractic Examiners (Board) enter into this stipulation pursuant to ORS 684.100(9) for the purpose of concluding the Board initiated disciplinary proceeding concerning aiding and abetting the practice of the healing arts by . an unlicensed student from Western States Chiropractic College.

Pursuant to ORS 183.415(5) and ORS 684.100(9), the Board and Ellsworth stipulate and agree that this disciplinary proceeding initiated by the Board may be concluded by entry of this Stipulation with the following terms and conditions:

NOW THEREFORE, IT IS STIPULATED by the parties that,

- a. Ellsworth waives any and all of his rights from all sources and to further notices, hearings and judicial reviews.
- b. Ellsworth agrees that the Board has jurisdiction over the matters of conduct which violate ORS 684.100(1)(p), and that, by his conduct, he has violated the above listed statute.
- c. Ellsworth is assessed a civil penalty of \$1000 which will be paid on or before September 9, 1991.

- e. Ellsworth will serve a probationary period of one (1) year, immediately following the period of suspension. This period of probation will be in effect from March 9, 1992 through March 9, 1993.
- f. During the period of probation, Ellsworth will furnish to the Board the name, address and job description of each employee of the clinic, as well as a copy of any contracts for independent contractors working in the clinic.
- g. Ellsworth will not, at any time he is licensed to practice chiropractic in Oregon, allow interns or students of chiropractic to work in his clinic.
- h. In any public statements or press releases, Ellsworth will not contradict the admissions made in nor the terms of this Stipulation.

This Stipulation is intended to cover the acts and practices denoted herein. This Stipulation does not cover actions which are not described herein. Ellsworth expressly waives any objection as to the form of the proceedings and service of documents.
