7 Steven Ellsworth (Ellsworth) and the Oregon Board of
8 Chiropractic Examiners (Board) enter into this stipulation pursuant
9 to ORS 684.100(9) for the purpose of concluding the Board initiated
10 disciplinary proceeding concerning aiding and abetting the practice
11 of the healing arts by an unlicensed student from
12 Western States Chiropractic College.

13 2.

14 Pursuant to ORS 183.415(5) and ORS 684.100(9), the Board and
15 Ellsworth stipulate and agree that this disciplinary proceeding
16 initiated by the Board may be concluded by entry of this
17 Stipulation with the following terms and conditions:

18 3.

19 NOW THEREFORE, IT IS STIPULATED by the parties that,

20 a. Ellsworth waives any and all of his rights from all
21 sources and to further notices, hearings and judicial reviews.

22 b. Ellsworth agrees that the Board has jurisdiction over
23 the matters of conduct which violate ORS 684.100(1)(p), and that,
24 by his conduct, he has violated the above listed statute.

25 c. Ellsworth is assessed a civil penalty of \$1000 which
26 will be paid on or before September 9, 1991.

1 d. Ellsworth's license to practice chiropractic in Oregon
2 is suspended for a period of six (6) months, commencing September
3 9, 1991 and ending March 9, 1992.

4 e. Ellsworth will serve a probationary period of one (1)
5 year, immediately following the period of suspension. This period
6 of probation will be in effect from March 9, 1992 through March 9,
7 1993.

8 f. During the period of probation, Ellsworth will furnish
9 to the Board the name, address and job description of each employee
10 of the clinic, as well as a copy of any contracts for independent
11 contractors working in the clinic.

12 g. Ellsworth will not, at any time he is licensed to
13 practice chiropractic in Oregon, allow interns or students of
14 chiropractic to work in his clinic.

15 h. In any public statements or press releases, Ellsworth
16 will not contradict the admissions made in nor the terms of this
17 stipulation.

18 4.

19 This Stipulation is intended to cover the acts and practices
20 denoted herein. This Stipulation does not cover actions which are
21 not described herein. Ellsworth expressly waives any objection as
22 to the form of the proceedings and service of documents.
