STIPULATED FINAL ORDER  
RESOLVING CASES NO.  
3038-93 AND 3045-93

Pursuant to ORS 684.100, the above-entitled matters came before the Oregon Board of Chiropractic Examiners (OBCE) on the complaint of Lopez, Neeley, Neeley and a licensee.

In order to informally dispose and settle these matters (cases No. 3038-93 and 3045-93) pursuant to ORS 183.415(5) and 684.155, Robert F. Fischel, D.C. (Dr. Fischel) and the OBCE, by and through its Executive Director, Christie Joachim, make the following statements:

1. Dr. Fischel is a licensed chiropractic physician in the State of Oregon subject to the jurisdiction of the OBCE, which is the state agency responsible for licensing and regulating chiropractic in the State of Oregon.
2. Dr. Fischel hereby voluntarily surrenders his Oregon chiropractic license effective upon execution of this agreement.
3. The OBCE dismisses with prejudice cases No. 3038-93 and 3045-93.
4. The OBCE hereby accepts effective immediately Dr. Fischel's resignation of his Oregon chiropractic license.
5. The OBCE makes no Findings of Fact or Conclusions of Law concerning cases No. 3038-93 or 3045-93.

1 6. Dr. Fischel admits and stipulates that he has been  
2 advised of his right to a hearing in this matter pursuant to ORS  
3 183.415(2)(a) and 183.430, and of his right to be represented at  
4 hearing pursuant to ORS 183.415(3).

5 7. If the OBCE finds, after a contested case hearing, that  
6 Dr. Fischel has materially violated any of the terms of this  
7 Stipulated Final Order, that violation shall constitute grounds  
8 for revocation of his Oregon chiropractic license.
