8 On March 21, 1991, the Board of Chiropractic Examiners  
9 (Board) held a meeting wherein it considered the findings of the  
10 Peer Review investigation of the complaint filed by  
11 alleging that Dr. Graffeo did not keep complete detailed records  
12 relative to his diagnostic and therapeutic procedures and that he  
13 provided excessive treatment to a patient.

16 Dr. Graffeo stipulates and agrees that the Board has grounds  
17 to impose disciplinary action against him for the reason that he  
18 engaged in conduct which violated ORS 684.100(1)(g)(B), OAR 811-15-  
19 010(1) and OAR 811-15-010(2)(a).

21 Pursuant to ORS 183.415(5) and ORS 684.100(9), the Board and  
22 Dr. Graffeo wish to compromise and settle this matter by  
23 stipulation.

25 NOW THEREFORE, in consideration of the mutual covenants and  
26 agreements contained herein, the Board and Dr. Graffeo stipulate  
27 and agree that:

1 A. Dr. Graffeo agrees to forward to the Board, on a  
2 monthly basis, a list of all new patients. This information is to  
3 be provided to the Board for a period of 12 months from the signing  
4 of this stipulation. Further, Dr. Graffeo agrees that the Board or  
5 an authorized representative of the Board may, with reasonable  
6 notice, monitor the chart notes of these patients during the 12  
7 month period described above to ensure compliance with applicable  
8 statutes and administrative rules.

9 B. Dr. Graffeo agrees to enroll in and complete, with a  
10 passing score, the next available course in Jurisprudence and  
11 Reporting, Module VII, Session 22 of the Diplomate Program in  
12 Chiropractic Orthopedics taught by Dr. Richard D. Stonebrink at  
13 Western States Chiropractic College. This course is to be in  
14 addition to the continuing education required in ORS 684.092 and  
15 OAR 811-15-025.

17 This stipulation is conditioned on Dr. Graffeo's complying  
18 with the terms herein. If the Board obtains evidence that Dr.  
19 Graffeo has violated the terms of this stipulation, the Board may  
20 institute disciplinary action based upon the findings of the Peer  
21 Review Committee, in accordance with ORS ch 183, ORS ch 684 and OAR  
22 ch 811. If Dr. Graffeo completes the terms of this stipulation, the  
23 Board will take no further action based on the conduct described in  
24 the Peer Review findings
