The Board of Chiropractic Examiners (Board) is the state agency responsible for licensing, regulating and disciplining chiropractic physicians in the State of Oregon. Bryon Hulsey DC. (Licensee), is licensed by the Board to practice as a chiropractic physician in the State of Oregon.

2.

On November 26, 2013, the Office of the Clackamas County District Attorney -- SED (enforcing agency) has informed the Board that Licensee owes child support and arrears. According to the information provided to the Board Licensee has not entered into an agreement with the enforcing agency. The enforcing agency certifies that proper notice and opportunity to contest the suspension have been provided to Licensee pursuant to ORS 25.750 through ORS 25.783. Under these conditions, Licensee's license to practice chiropractic is subject to suspension, ORS 25.750.

3.

The Board therefore suspended Licensee's license to practice chiropractic effective Monday, January 13, 2014, pursuant to ORS 25.780. The Board received the request from Clackamas County District Attorney -- SED to reinstate his license on January 15, 2014, however, the request was dated January 13, 2014.


