STIPULATED AGREEMENT Surrender of License In Lieu of Revocation and Emergency Suspension

Pursuant to ORS 684.100, the above-entitled matter came before the Oregon Board of Chiropractic Examiners (OBCE) on the complaint of four female patients.

Pursuant to ORS 183.415(5) and ORS 684.155, in order to informally dispose of and settle this matter, John R. Johnson, D.C. (Johnson), and the OBCE by and through its Administrator, Christie Joachim, make the following statements:

1.

Johnson admits and stipulates that he has been advised of his right to a hearing in this matter pursuant to ORS 183.415(2)(a) and ORS 183.430 and his right to be represented at a hearing pursuant to ORS 183.415(3).

2.

Johnson waives his right to such a hearing in this matter.

Under ORS 684.090(2) Johnson's license (license number #1074) as a chiropractic physician expires on July 31, 1995.

The OBCE and Johnson stipulate and agree that in lieu of hearing on the emergency suspension and revocation of Johnson's license to practice as a chiropractic physician:

- That Johnson agrees not to practice chiropractic, or any (a) ancillary practice as defined by ORS 684.155(1)(c), from the date of entry of this order;
- That in lieu of a hearing on the incidents alleged in the May 22, 1995 Notice of Proposed Revocation and Emergency Suspension Order and all other complaints lodged against Johnson with the OBCE to date, Johnson surrender to the OBCE his license to practice chiropractic in the state of Oregon on the date of entry of this order;
- That on the date of entry into this agreement, Johnson (C) hereby requests that chiropractic license #1074 not be renewed and further requests that his license be treated as lapsed notwithstanding ORS 684.090;
- (d) That the OBCE hereby accepts Johnson's surrender of his license to practice chiropractic in the state of Oregon;
- (e) That on or before midnight of the day Johnson affixes his signature to this Stipulation, Johnson will surrender all documents evidencing his rights to practice as chiropractic physician in Oregon to the OBCE offices at 3218 Pringle Road SE, Salem, Oregon 97302;
- (f) That Johnson will not seek licensure with the OBCE at any time in the future;
- (g) The OBCE may publicize this Stipulated Agreement by the announcement in the OBCE's own newsletter and, if it so chooses, in the Oregonian;
- (h) That the OBCE and Johnson agree that this agreement is not an admission of unprofessional conduct on the part of Johnson.
- That upon Johnson's performance of the requirements in this Stipulated Final Order, the May 22, 1995 Notice of Revocation and Emergency Suspension Order are dismissed with prejudice.

If the OBCE finds, after a contested case hearing, that Johnson has materially violated any of the terms of this Stipulation, that violation shall constitute grounds for revocation and Johnson's license may be immediately revoked.
