Case # 2011-1012, 2012-1025, 11 12 2011-1026, 2011-1027 13 14 The Board of Chiropractic Examiners (Board) is the state agency responsible for licensing, regulating and disciplining chiropractic physicians in the State of Oregon. Mike 15 LeBoss (Respondent) is not licensed by the Board to practice as a chiropractic physician in the 16 17 State of Oregon. 18 19 1. In April 2011 the Board received complaints that Respondent was practicing chiropractic 20 without a license based on information obtained from patients who had received treatment from 21 him in the Newport, Oregon area. The original complaint was from someone who claimed they 22 had been injured by Respondent while receiving treatment from him as a "trainer." These 23 adjustments occurred in the gym where Respondent was working. 24 25 26 Respondent denied that he was doing chiropractic manipulations but said he did lifestyle and nutritional coaching, muscle balancing as a trainer, stretching with clients, muscle release 27 techniques using pressure points and exercises to balance muscular imbalances. 28 29 30 2. 31 Patient 1 met Respondent while in a gym lobby and he indicated to her he could fix her hip imbalance and offered his services. She told Respondent she had a history of low back disc 32 disease and had seen chiropractors regularly since 1996. After moving to Newport in 2006, she 33 had not seen a chiropractor. During the first visit, he completed a chiropractic adjustment. He 34 told Patient 1 that he was trained in multiple modalities and would add strength training to a 35 36 therapy routine to assist her. He presented himself as fully competent to perform a myriad of vertebral adjustments, similar to the ones she had received from a chiropractor. He charged 37 Patient 1 \$40 per session. 38 39 40 During one adjustment where he pulled her head directly backwards while lying on her back. Patient 1 immediately felt pain radiate down towards her left thoracic region. She left after 41

that treatment and contacted Respondent stating she was in pain to that region for several weeks. She then went to a physician.

Patient 1 stated that Respondent discussed treating other clients with her, several of whom had scoliosis.

The Board became aware of two additional patients, Patient 2 and Patient 3 who had received painful adjustment procedures from Respondent, one on more than one occasion.

Patient 1 was treated 2-3 times over a 2 year period. She complained that her knee hurt and he said he could help. She had knee surgery 3 years prior and was nervous about getting treatment on that leg. Respondent treated Patient 2 a total of three times in his office. He would begin by stretching her, and then begin adjustment, like giving her a bear hug. He also did cervical adjustments while she was face up by turning her head sharply to either side until the neck cracked with sound. Patient 2 said Respondent referenced all these adjustments by saying that her knee pain and stiffness were all interrelated and that all areas needed to be treated to alleviate pain. The adjustments on her neck, hips and leg were painful. She did not receive a complete check of other injury history, nor an exam. She did not recall Respondent writing any of the information down. Patient 2 discontinued seeing Respondent because of the pain inflicted.

Patient 3 suffered from hip and back pain for many years. She had met Respondent in the gym and had agreed to get some stretching treatment when Respondent put her on the table and began manipulating her legs without warning, jerking on her leg. She cried out in pain, saying "what are you doing?" Respondent laughed and said "I suffer from the same thing, I know how to help." He also had her stand facing the wall, put her hands behind her head and stood behind her linking his hands somehow behind hers and leaned back, lifted her and cracked her back. He was insistent about cracking her neck but she told him she had it fused and to not do so. She only had any treatment from him on one occasion.

5.

Respondent is not a licensed Chiropractor in the State of Oregon. Respondent holds no other health regulatory licenses or certificates in the State of Oregon. Respondent is performing chiropractic techniques as described by ORS 684.010(2) and is performing techniques that are taught in chiropractic schools. Patients 1, 2 and 3 have reported harmful treatments from Respondent. Respondent is risking causing harm to other patients that he has provided this treatment to.

The Board finds that conduct described above is a violation of ORS 684.015(a), 684.020(1), ORS 684.100(1)(f) (a), and (q), OAR 811-035-0015(6), (12), and (14) that Respondent practiced chiropractic without a license and engaged in unprofessional conduct. The Board finds that the Respondent's conduct exposed the citizens of Oregon to great harm.

3	Due to the aforementioned violations, the OBCE proposes to require Respondent to pay a				
4	civil penalty in the sum of \$10,000 to the Board. This is pursuant to their authority under ORS				
5	684.100(9). Payment of the civil penalty is due within 30 days of this order becoming final. The				
6	Board also orders that Respondent cease and desist from performing any chiropractic treatment				
7	including adjustment and/or manipulations.

10	Respondent shall pay costs of this disciplinary proceeding, including investigative costs				
11	and attorney fees pursuant to ORS 684.100(9)(g).

14	Respondent has the right, if Respondent requests, to have a formal contested case hearing				
15	before the Office of Administrative Hearings to contest the matter set out above. At the hearing,				
16	Respondent may be represented by an attorney and subpoena and cross examine witnesses. That				
17	request for hearing must be made in writing to the OBCE, must be received by the OBCE within				
18	30 days from the mailing of this notice (or if not mailed, the date of personal service), and must				
19	be accompanied by a written answer to the charges contained in this notice.

22	If Respondent requests a hearing, before commencement of that hearing, Respondent will				
23	be given information on the procedures, rights of representation and other rights of the parties				
24	relating to the conduct of the hearing as required under ORS 183.413-415.

28	If Respondent fails to request a hearing within 30 days, or fails to appear as scheduled at

32	disciplinary action upon default for the purpose of proving a prima facie case.
