The Oregon Board of Chiropractic Examiners (hereafter "Board" or "OBCE") is the state agency responsible for licensing, regulating and disciplining chiropractic physicians and certified chiropractic assistants in the State of Oregon. Adam Lopez, D.C. (hereafter "Licensee"), is a licensed chiropractic physician in Oregon.

## Summary of Facts

1.

In October 2004, Patient 1 became a patient of Licensee. Patient 1's family was also treated by Licensee. During treatment, Patient 1 and Licensee established a close friendship and began to discuss their personal and family issues. Beginning in January 2005 Licensee and Patient 1 consummated an intimate sexual relationship that was concealed from their respective spouses. The relationship continued with numerous sexual encounters, telephone conversations, e mails, shared meals and personal meetings. Chart notes indicate that Licensee treated Patient 1 from October 2004 through April 2005. In April 2005, Licensee terminated Patient 1 as a patient via letter.

In an interview with the Board in May 2006, Licensee admitted he had a sexual affair with Patient 1 and told the Board investigator that they consummated a sexual relationship in January 2005 that lasted through March 2005 while Patient 1 said that it ended sometime in April 2005. Licensee explained that he had given in to temptation and attempted to conceal the relationship from his family. Licensee accepted that Patient 1 was in fact a patient and his conduct was unprofessional.

3.

The Board alleged in the Notice of Discipline that Licensee's conduct as described herein constitutes unprofessional conduct. Licensee's practice, as described above, constitutes violations of ORS 684.100 (1)(g)(A); and OAR 811-035-0015(1)(b)-(e).

4.

On May 25, 2006, a Notice of Proposed Discipline was served on Licensee. That notice proposed a 30 day suspension, a probation of three years, attendance of the PROBE ethics program and a \$5000 civil penalty. In the Notice of Discipline, Licensee was notified that if he did not request a hearing in writing within 30 days a default order would be issued and the Board file would become the evidentiary record for the default. Licensee did not request a hearing in writing.

## Conclusions of Law

5.

The Board finds that Licensee's conduct as described herein constitutes a violation of laws and rules and is unprofessional conduct. Licensee's practice, as described above, constitutes violations of ORS 684.100 (1)(g)(A); and OAR 811-035-0015(1)(b)-(e).

## **ORDER**

6.

The Board finds Licensee in violation of ORS 684.100(1)(g)(A) and OAR 811-035-0015(1)(b)-(e) and orders Licensee to complete the following:

- Licensee's Licensee to practice Chiropractic is hereby suspended for 30 days beginning August 1, 2006 through August 31, 2006. Licensee may not participate in any type of practice of chiropractic during that time period.
- 2. Licensee is placed on Probation for a period of three years from the date of completion of the suspension.
- 3. Licensee must attend and complete the PROBE ethics program in September or November 2006 at his own expense and provide proof of completion of the program to the Board within thirty days of completion.
- 4. Licensee is assessed a civil penalty in the sum of \$5000 payable to the Board within 30 days of this signed order.
- 5. Licensee must participate in appearing before Western States Chiropractic

  School students to discuss what he gained from his experience in the PROBE

program upon request of the Board at least three times in the next three years from the date this order is signed.

6. Further violations of this final order may result in further discipline up to and including revocation of the license.



Adam Lopez, D.C. (hereafter "Licensee"), is a licensed chiropractic physician in Oregon. The Board proposes to discipline Licensee for the following reasons:

1.

The Board finds that Licensee's conduct as described herein constitutes unprofessional conduct. Licensee's practice, as described above, constitutes violations of ORS 684.100 (1)(g)(A); and OAR 811-035-0015(1)(b)-(e).

Due to the aforementioned violations, the OBCE proposes to suspend Licensee's Licensee for a period of 30 days as of the date of this effective date of the final order in this matter, that Licensee is placed on probation for a period of 3 years following the conclusion of the suspension, that Licensee must attend and complete the PROBE ethics program (either in September 2006 or November 2006) and provide proof of completion to the Board within that time period, and be assessed a civil penalty in the sum of \$5000, payable within 30 days of the final order. Licensee must also participate in appearing before Western States chiropractic students to discuss what he learned at the PROBE program upon request of the Board at least three times in the next thee years.

Licensee shall pay costs of this disciplinary proceeding, including investigative costs and attorney fees pursuant to ORS 684.100(9)(g).

6.

Licensee has the right, if Licensee requests, to have a formal contested case hearing before the OBCE or its Administrative Law Judge to contest the matter set out above. At the hearing, Licensee may be represented by an attorney and subpoena and cross-examine witnesses. That request for hearing must be made in writing to the OBCE, must be received by the OBCE within 30 days from the mailing of this notice (or if not mailed, the date of personal service), and must be accompanied by a written answer to the charges contained in this notice.

7.

The answer shall be made in writing to the OBCE and shall include an admission or denial of each factual matter alleged in this notice, and a short plain statement of each relevant affirmative defense Licensee may have. Except for good cause, factual matters alleged in this notice and not denied in the answer will be considered a waiver of such defense; new matters alleged in this answer (affirmative defenses) shall be presumed to be denied by the agency and evidence shall not be taken on any issue not raised in the notice and answer.

8.

If Licensee requests a hearing, before commencement of that hearing, Licensee will be given information on the procedures, rights of representation and other rights of the parties relating to the conduct of the hearing as required under ORS 183.413-415.

9.

If Licensee fails to request a hearing within 30 days, or fails to appear as scheduled at the hearing, the OBCE may issue a final order by default and impose the above sanctions against Licensee. Upon default order of the Board or failure to appear, the contents of the Board's file regarding the subject of this automatically become part of the evidentiary record of this disciplinary action upon default for the purpose of proving a prima facie case.



## A LITTLE E GROUND.....

Intervention in ethics for health care practitioners who are under discipline by their licensing boards, hospital or other oversight agencies. It is unique in addressing the specific and individual ethical difficulty that occasioned the sanction. Originally designed for physicians, the range of professional ethics it addresses is applicable to all health care professionals. Participants have included practitioners from dentistry, musing, podiatry, chiropractic, acupuncture, and physicians assistants.

First developed in 1992 for the State of New Jersey Board of Medical Examiners, The ProBE Program has been subscribed to and/or approved for continuing medical education in professional chiics by 39 state liceusing boards in the United States as well as several specialty boards.

The ProBE Program is registered in the Health Provider Assessment and Remediation Resource Manual (US HRSA, DHHS, Washington, DC: 2003); and, in the Directory of physician assessment and remedial education programs, (Federation of State Medical Boards: 2005). The Ethics Group, LLC is a member of the Coalition for Physician Enhancement, an organization of universities and other agencies devoted to promoting excellence in patient care through personalized assessment and education of individual physicians.

L PM Session I - The "Good Dector"

What are the characteristic qualities of good doctor? An exercise to elicit from the participants an ideal vision of the desired virtues expected of a health professional.

SAT. AM Session 2 - Infractions, Sanctions and Discipline

# Final Essay, Evaluation, and Assessment

ESSAY (3-4 typewritten, double-spaced pages), which relates the substance of The ProBE Program to the particular violation that lead to participation. Specific course readings and/or class discussions should be identified and explored in terms of how participant hefore the Specific problem that before the Board or other agency. The essay should sum up what was fearned. The syllabus contains guidelines to assist in formulating this summary.

This essay must be completed and returned to THE ETHICS GROUP, u.c. within two weeks of the program. Along with other elements of participation, the essay is required for certification of successful completion of The ProBB Program. It will be forwarded to the licensing board (or other agency), together with commentary by the faculty.

Ache basis of the quality of participation, and completion of the assignments. A detailed letter of assessment is sent to the appropriate licensing board or other agency for each person who completes all course elements. It includes, (1) certification of participation; (2) the final essay with faculty commentary; and, (3) an overall evaluation of the participant's capacities for ethical reasoning and insight as demonstrated over the whole course of The ProBE Program. A copy of this assessment letter is sent to the participant along with a certificate of completion.

ENROLLMENT IN THE ProBE Program is limited to an optimal group of 12-14 participants to assure a balance of effective peer exchange and attention to the individual. To assure enrollment for the desired and timely session, early application is therefore strongly recommended.

Eurollment must be reserved with an initial deposit of \$200 with the full tuition of \$1200 payable three weeks before the selected weekend. The tuition includes the teaching materials (a 150 page syllabus of readings, cases and exercise assignments), all refreshment breaks, and Saturday's luncheon.

Lodging in both the New Jersey and Colorado locations is discounted at group rate, and along with travel and any other expenses, is the responsibility of the participant.
