) CONSENT ORDER

The Oregon Board of Chiropractic Examiners (hereafter "Board") is the state agency responsible for licensing, regulating and disciplining chiropractic physicians in the State of Oregon. Jason C. Morris (hereafter "Licensee"), is currently licensed by the Board as an Inactive Oregon chiropractic physician. He has had an active chiropractic license in Arizona since 2000 and currently practices there.

FINDINGS OF FACT

1.

On August 4, 2006, Licensee signed a Consent Order agreement with the Board in regards to his previous convictions for DUI in Arizona, one of which was an extreme DUI. This resulted in a fine, ten days in jail, 36 hours of alcohol counseling, and evaluation by Dr. Michel A. Sucher MD, an addictionologist. Licensee attended 16 AA meetings as part of his counseling program. Dr. Sucher's recommendations are for further evaluation with continued treatment, or alternatively diagnostic monitoring for the purpose of ruling out a diagnosis of alcohol dependence. In this Consent Order licensee agreed to abide by the terms of his Arizona Board order and may UA reports to the OBCE for twelve months.

On Licensee's license renewal form dated December 22, 2009, Licensee reported a new DUI in Arizona which resulted in a misdemeanor conviction and pending action before the Arizona Board of Chiropractic Examiners (ABCE). In a Final Order with the ABCE dated March 15, 2010, Licensee was placed on a five-year probation with a Board approved monitor and required to receive an addiction and behavioral evaluation, participate in a relapse prevention program, a 12 step recovery program, submit to random UA testing, and completely abstain from alcohol and possession of controlled substances, and other provisions.

## CONCLUSIONS OF LAW

3.

The above described conduct of Licensee violates ORS 670.280, ORS 684.100(1)(e), ORS 684.100 (1)(f)(A), and OAR 811-035-0015(13).

## CONSENT ORDER

4.

Licensee and the Board agree to the entry of this Consent Order, which provides that Licensee shall comply with the following as a condition on his inactive Oregon chiropractic license:

1. Licensee agrees to fully comply with the terms of the Arizona Board of Chiropractic Examiners decision in their Case # 2009-049, as a condition of his Oregon Inactive chiropractic license, including any provision that he maintain an active Arizona chiropractic license in good standing.
2. Licensee will abstain from all use of alcohol.
3. Licensee will cause his random UA reports to be sent to this Board.
4. Licensee agrees that any application to change his Oregon license status to Active will be reviewed by the Board; and that he must have completed the terms of his probation with the Arizona Board of Chiropractic Examiners; and that he must continue his program of regular random UAs at a frequency and facility approved by the Board until relieved of that obligation by the Board, and he must be able to prove a long period of sobriety.
5. Licensee shall instruct all health care providers participating in any treatment program to respond promptly to any Board inquiry concerning Licensee's compliance with the treatment plan.
6. Licensee shall waive any privilege with respect to any physical or psychological evaluation or treatment in favor of the Board for the purposes to determine compliance with this Order and shall execute any waiver or release upon request from the Board.
7. Licensee agrees that any violation of this Consent Order agreement provides the basis for further disciplinary action, up to and including license revocation.
