FINDINGS OF FACT

In 2007 Licensee signed a Renewal Notice and Affidavit filed on July 20, 2007 affirming that he had completed the required number of continuing education credits required for license renewal. The renewal application stated "I swear, and affirm that during the previous license year, I completed the required number of CE credits for my license status and my signature below verifies that all information hereon is true and correct." Licensee was required to complete the CE by July 31, 2007.

However, upon audit and review by the Board of the credits that were actually taken by Licensee during the required period, of the 20 that were required, Licensee was missing 14 hours of CE credits and had only completed six. Once Licensee was aware of the Board audit. Licensee took 14 additional hours in a good faith effort to respond to the audit, however, those were not accomplished during the time period required. Those 14 hours were completed in December 2007.

Licensee stated the omissions and violations were inadvertent and not intentional. He stated he misread some of the C.E. dates and said it was the first time in 24 years he has been short on continuing education hours.

Stimulated Final Order (Joffrey, S. Molgan DC)

The Board finds that Licensee's failure to complete the CE within the time period required is a violation of OAR 811-15-0025, ORS 684.092 and 811-035-0015(16).

ORDER: Licensee is issued a \$950 civil penalty due to the above mentioned violations payable within 30 days. In addition, for the next five years of renewal, Licensee shall provide copies of all CE taken to the Board with the renewal application.
