14 The Oregon Board of Chiropractic Examiners (hereafter "Board" or "OBCE") is the state
15 agency responsible for licensing, regulating and disciplining chiropractic physicians and certified
16 chiropractic assistants in the State of Oregon. Delbert H. Schaeffer D.C. (hereafter "Licensee") is
17 a licensed chiropractic physician in Oregon.

18 On August 10, 2011, the Board received a Certificate of Good Standing from the
19 Department of Revenue that pursuant to ORS 305.385(5) they requested that the Board reinstate
20 the suspended license of Licensee in that the taxpayer had agreed to an installment agreement
21 satisfactory to the Department of Revenue.

22 Based on their certificate of good standing, the Board hereby reinstates the license of
23 Licensee as to Active status on the date below.



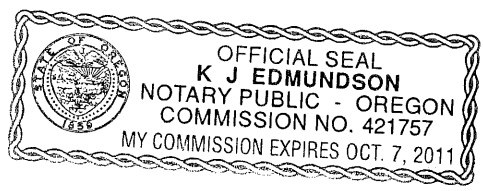


