STIPULATION

7
8 1.

9 On March 21, 1991, the Board of Chiropractic Examiners
10 (Board) held a meeting wherein it considered the findings of the
11 Peer Review investigation of the complaint filed by
12 alleging that Dr. Shields does not keep adequate chart or
 treatment records on his patients.

14 2.

15 Dr. Shields stipulates and agrees that the Board has grounds
16 to impose disciplinary action against him for the reason that he
17 has engaged in conduct which violated ORS 684.100(1)(j) and (s) and
18 OAR 811-15-005(1) in that he knowingly kept incomplete and non-
19 detailed records relative to diagnostic and therapeutic procedures.

20 3.

21 Pursuant to ORS 183.415(5) and ORS 684.100(9), the Board and
22 Dr. Shields wish to compromise and settle this matter by
23 stipulation.

24 4.

25 NOW, THEREFORE, in consideration of the mutual covenants and
26 agreements contained herein, the Board and Dr. Shields stipulate
27 and agree that:

1 A. The Board agrees to send Dr. Shields a copy of the
2 Oregon Chiropractic Practices and Utilization Guidelines for
3 Neuromusculoskeletal Conditions, Draft 2 for his study, with
4 particular attention to Chapter III.

5 B. Dr. Shields agrees to forward, to the Board, proof of
6 attendance at Dr. Michael J. Burke's class on charting. This
7 documentation is to be submitted within 10 days of the signing of
8 this stipulation.

9 C. Dr. Shields agrees to forward, to the Board on a
10 monthly basis, a list of all new patients. This information is to
11 be provided to the Board for a period of 12 months from the signing
12 of this stipulation. Further, Dr. Shields agrees that the Board, or
13 an authorized representative of the Board may, with reasonable
14 notice, monitor the chart notes of any of these patients during the
15 12 month period described above to ensure compliance with
16 applicable statutes and administrative rules.


18 This stipulation is conditioned on Dr. Shields complying
19 with the terms appearing herein. If the Board obtains evidence that
20 Dr. Shields has violated the terms of this stipulation, the Board
21 may institute disciplinary action based on the findings of the Peer
22 Review Committee, in accordance with ORS ch 183, ORS ch 684, and
23 OAR ch 811. If Dr. Shields completes the terms and conditions of
24 this stipulation, the Board will take no further action based on
25 the Peer Review investigation described in this stipulation.


