STIPULATION

1.

On March 21, 1991, the Board of Chiropractic Examiners (Board) held a meeting wherein it considered the findings of the Peer Review investigation of the complaint filed by

alleging that Dr. Shields does not keep adequate chart or treatment records on his patients.

Dr. Shields stipulates and agrees that the Board has grounds to impose disciplinary action against him for the reason that he has engaged in conduct which violated ORS 684.100(1)(j) and (s) and OAR 811-15-005(1) in that he knowingly kept incomplete and nondetailed records relative to diagnostic and therapeutic procedures.

Pursuant to ORS 183.415(5) and ORS 684.100(9), the Board and Shields wish to compromise and settle this matter by stipulation.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the Board and Dr. Shields stipulate and agree that:

B. Dr. Shields agrees to forward, to the Board, proof of attendance at Dr. Michael J. Burke's class on charting. This documentation is to be submitted within 10 days of the signing of this stipulation.

monthly basis, a list of all new patients. This information is to be provided to the Board for a period of 12 months from the signing of this stipulation. Further, Dr. Shields agrees that the Board, or an authorized representative of the Board may, with reasonable notice, monitor the chart notes of any of these patients during the 12 month period described above to ensure compliance with applicable statutes and administrative rules.

4.

This stipulation is conditioned on Dr. Shields complying with the terms appearing herein. If the Board obtains evidence that Dr. Shields has violated the terms of this stipulation, the Board may institute disciplinary action based on the findings of the Peer Review Committee, in accordance with ORS ch 183, ORS ch 684, and OAR ch 811. If Dr. Shields completes the terms and conditions of this stipulation, the Board will take no further action based on the Peer Review investigation described in this stipulation.
