The Oregon Board of Chiropractic Examiners (hereafter "Board" or "OBCF") is the state agency responsible for licensing, regulating, and disciplining chiropractic physicians and certified chiropractic assistants in the State of Oregon. Ashley C. Slaughter ("Applicant"), applied for a certificate as a certified chiropractic assistant in Oregon. The Board proposes to grant the certificate of the above applicant with specific restrictions based on the following basis:

FINDINGS OF FACT

1.

On November 1, 2017, the OBCE received Applicant's application for a certificate to practice as a certified chiropractic assistant in Oregon. On question five of the application, where Applicant was asked if she had ever been arrested or charged with a violation, misdemeanor or felony. Applicant responded yes. Applicant also stated on question 7 that she had been convicted or pled guilty to a misdemeanor or felony. In the attached explanation for that response, Applicant provided a statement that in July 2011, she was cited for reckless driving, eluding a police officer, and possession of a concealed firearm. She explained it was due to being in an abusive relationship and a domestic violence issue. In 2013, Applicant was also arrested for identity theft in relation to getting a prescription medication filled, but explained to the Board that someone had stolen her identity which caused the police to wrongly arrest her. She stated that the matter was dismissed and she was not eventually charged.

Applicant was convicted for the reckless driving, concealed weapon, and eluding the police; and received 18 months of supervised probation. 3 days incarceration, and an order to destroy the weapon and seize any cash to be paid to the drug store.

CONCLUSIONS OF LAW 2.

The Board finds that the acts and conduct of applicant in her application and responses to such, are cause to refuse to grant a certificate to Applicant. The Board may deny a certificate for

conviction of a misdemeanor involving motal turpitude or a felony pursuant to OAR 811-010-0110(14)(c). The Board finds that a felony conviction for unauthorized use of a motor vehicle and a misdemeanor conviction of possession of methamplictamine are crimes involving moral turpitude. The Board also finds that the facts and circumstances of the conviction bears a relationship to the specific professional standards and prevents the Board from determining that the Applicant is fit to hold the certificate under ORS 670.280.

ORDER

Therefore, pursuant to ORS 183.415(5) and ORS 684,100(9)(c) the OBCE orders;

- The parties have agreed to enter into this stipulated final order. Applicant agrees to the entering of this final order. Applicant agrees that she is aware of her right to a hearing with her attorney present to contest the charges and hereby waives that right and agrees to entry of this order. The signature of this order also waives any right to appeal. The parties wish to settle and resolve the above matter without further proceedings.
- 2. Applicant will receive her Certified Chiropractic Assistant Certificate.
- Applicant is required to notify all employers of her criminal arrests and convictions. Applicant agrees to notify her employer of this order and provide a copy to the employer.
- 4. Applicant agrees to abide by the terms of any remaining criminal probation requirements and agrees that the Board shall receive updates about the completion of her probation if applicable. Applicant agrees to instruct all professionals participating in her probation to promptly respond to the Board regarding her compliance and to immediately report any violations of her probation to the Board.
- 5. Failure to complete this final stipulated order with the terms so stated, may result in further discipline, up to and including, revocation.
- 6. This is a public document.
