13 The Board of Chiropractic Examiners (Board) is the state agency responsible for
14 licensing, regulating, and disciplining chiropractic physicians in the State of Oregon. David
15 Trommler, D.C. (Licensee), is licensed by the Board to practice as a chiropractic physician in the
16 State of Oregon. The Board proposes to discipline Licensee for the following reasons.

18 1.

19 In October 2016, A complaint was filed regarding treatment of Patient 1 alleging that
20 Licensee failed to provide an interim health history update on the patient, that he failed to
21 document he had performed a PARQ and to document that he had obtained informed consent to
22 treat the patient.

25 A letter summarizing the complaint was sent to Licensee on February 24, 2016, to his
26 address of record in Mesa, Arizona. A letter was also sent to his prior clinic location. The Board
27 received a letter from the new owner of the practice on March 3, 2016, informing them that
28 Licensee had moved to Arizona. In the February 2016 letter to Licensee, his response was
29 requested. Licensee failed to respond. As of May 19, 2016, Licensee has failed to respond. Later
30 in April 2016, the Board spoke with Licensee via telephone and he indicated he would get the
31 patient records from a prior employer and get in touch with the Board. Licensee failed to do so.

35 The Board finds that Licensee's failure to provide a response to the Board in regards to
36 the complaint and failure to cooperate with the Board investigation into this matter is a violation
37 of ORS 684.100 (1)(f); OAR 811-035-0015(19) and (20).

1 On June 2, 2016, Licensee was served with a Proposed Notice of Discipline. With that
2 document Licensee received indication if the matter went to default the Board would base its
3 final order on the record herein. Licensee was provided his contested case rights and did not
4 timely request a hearing. Licensee is now in default.

7 IT IS HEREBY ORDERED due to the aforementioned violations and Licensee being in
8 default, pursuant to ORS 684.100(9)(a) the OBCE suspends Licensee beginning July 25, 2016 for
9 a period of six months.
