14 The Oregon Board of Chiropractic Examiners (hereafter "Board" or "OBCE") is the state  
15 agency responsible for licensing, regulating and disciplining chiropractic physicians and certified  
16 chiropractic assistants in the State of Oregon. George Ulbrich DC (hereafter "Licensee"), is a  
17 Licensee to the Board to practice as a chiropractic physician in Oregon. On September 24,  
18 2013, the Department of Revenue intervened in this matter as an interested agency.

Dr. George Ulbrich DC is a chiropractor licensed under ORS 684.054 who has practiced at 6422 SE Milwaukie Avenue, Portland, Oregon, 97202.

Licensee has neglected or refused to file any tax return or pay any tax owed to the Oregon Department of Revenue, has not filed a good faith petition before the Department of Revenue and the Department of Revenue, has been unable to obtain payment of the tax through other methods of collection. The above information was provided by the Department of Revenue and was based on neglect or refusal to pay personal income taxes from years 2000, 2002-2010 and self employment taxes from 2001- 2006.

On June 13, 2013 the OBCE received notice (Exhibit A) of Licensee's deficiencies of tax payment and a request from the director of the Oregon Department of Revenue to suspend Licensee's business license.

On September 23, 2013 the Board issued a Proposed Notice of Suspension of Licensure to Licensee via mail, both certified and regular mail. In the notice, Licensee was advised to request a hearing within 30 days. By October 23, 2013 or since, no request for hearing was received. In the Proposed Notice Licensee was warned that a default order could be issued based on the Board's record and if Licensee defaulted it would be used as the prima facie case. The Licensee is in default as he has failed to request a hearing.

CONCLUSIONS

5.

The Board finds that the above described acts of Licensee constitute violations of ORS chapter 305.385 4 (c).

ORDER

6.

Therefore, pursuant to ORS 305.385 the Board hereby suspends Licensee's license to practice chiropractic in the State of Oregon. Licensee's suspension will be lifted upon notice and request from the Oregon Department of Revenue.

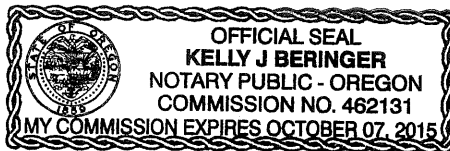
