)	STIPULATED FINAL ORDER

The Oregon Board of Chiropractic Examiners (hereafter "Board" or "OBCE") is the state agency responsible for licensing, regulating and disciplining chiropractic physicians and certified chiropractic assistants in the State of Oregon. Tracy Ann Walker (hereafter "CCA"), is a licensed certified chiropractic assistant in Oregon. The Board has determined the facts as follows:

1.

On July 6, 2000, the OBCE received CCA's application for a certificate to practice as a certified chiropractic assistant in Oregon. All requirements of the application process were met and the application was forwarded to Executive Director Dave McTeague for initial approval. CCA certified in question number 3 that she had not been arrested for, or charged with, a violation, misdemeanor or felony on July 6, 2000. A license for CCA was issued on August 2, 2000.

2.

Further investigation by the OBCE revealed that CCA had provided a false answer on her application response to question number 3. On the application CCA certified that all statements were true and correct. CCA was indicted on June 2, 2000 by a Lane County Grand Jury and was issued an arrest warrant for Aggravated Theft in the First Degree. On June 6, 2000, CCA appeared before her arraignment and was charged with Aggravated Theft in the First Degree to which she pled not guilty. On July 12, 2000 CCA was arraigned on two additional counts of Aggravated Theft in the First Degree to which CCA plead not guilty. On September 13, 2000 CCA changed her plea and pled guilty to three counts of Aggravated Theft in the First Degree (Three Class B Felonies) in the Lane County Circuit Court. On November 15, 2000 CCA was sentenced and ordered to pay restitution in the amount of \$94,831.46.

3.

After requesting a contested case hearing and writing to the Board with further explanation, CCA appeared for a personal with the Board of Chiropractic Examiners on September 20, 2001.

4.

Conclusions of Law

The Board finds that Licensee's conduct as described herein constitutes violations of OAR 811-010-0110(15) (a), (b) and (c).

5.

Stipulations

This matter having come properly before and been considered by the Board, and CCA having voluntarily stipulated and consented to the issuance and entry of this order by signing below,

IT IS HEREBY ORDERED THAT:

1. Pursuant to ORS 183.415(5), the Board and Licensee agree to informally dispose of and settle this matter.
2. CCA stipulates that she has been advised of his right to request a hearing in this matter pursuant to ORS 183.415(2)(a), and to be represented at a hearing pursuant to ORS 183.415(3).
3. CCA waives her right to a hearing in this matter.
4. CCA shall not be allowed access to any work situation in a chiropractic clinic which involves the handling of finances or money in any way.
5. CCA will report to her present and any future chiropractic employer the full nature of her conviction and the terms of this Stipulated Final Order.
6. CCA will comply with all the terms of her court order and probation.

I have read and I fully understand all of the above Stipulated Final Order and fully agree to its terms.
