Ţ	jurisdiction of the matter of adequate recordkeeping concerning
15	the chiropractic profession, especially with respect to patient
16	records. Dr. Wenneker agrees and stipulates that, by his actions
17	described above, he has violated OAR 811-15-005(1) and
18	ORS 684.100(1)(s). The OBCE and Dr. Wenneker stipulate and agree
19	that a disciplinary proceeding initiated by the OBCE may be
20	concluded by entry of this Stipulation with the following terms

8	denoted herein. This Stipulation does not cover actions which are

10	as to the form of the proceedings and service of documents
