Licensee.) STIPULATED FINAL ORDER

The Oregon Board of Chiropractic Examiners (OBCE) is the state agency responsible for licensing chiropractic physicians in the State of Oregon. Thomas Wright, D.C. (Dr. Wright), is a licensed chiropractic physician in Oregon.

Pursuant to ORS 183.415(5), in order to informally dispose of and settle this matter, the OBCE and Dr. Wright agree that the following facts are true:

1.

Dr. Wright is practicing chiropractic at the Gresham Chiropractic Clinic, 575 N.E. 2nd, Gresham, Oregon 97030, and has advertised free "X-rays". A copy of Licensee's flyer advertisement is attached hereto and marked Exhibit A.

2.

On July 5, 1994, Dr. Wright received a letter from the OBCE notifying him not to advertise free radiographs.

3.

On October 20, 1994, the OBCE issued a Notice of Proposed Civil Penalty, alleging that Dr. Wright violated ORS 684.100 and

1 OAR 811-30-020(8) and proposed to impose civil penalties and
2 assess costs of this disciplinary proceeding against Dr. Wright.

4 On October 25, 1994, the OBCE received a letter from
5 Dr. Wright stating that he felt it was an unintentional action on
6 his part to not comply with the administrative rules and that the
7 penalty proposed, in his opinion, was unwarranted.

8 5.

9 After speaking with the OBCE regarding the fine imposed on
10 Dr. Wright, the OBCE received a letter from Dr. Wright dated
11 January 17, 1995, wherein Dr. Wright made an appeal to the OBCE to
12 accept \$200 as full payment, and apologized to the OBCE for his
13 unintentional action regarding the advertising of radiographs.

14 6.

15 To avoid the costs and risks of proceeding to hearing, the
16 OBCE and Dr. Wright stipulate and agree as follows:

17 6.1 Dr. Wright admits that advertising free radiographs is
18 unprofessional conduct and in violation of ORS 684.100(1)(g)(B)
19 and OAR 811-30-020(8).

20 6.2 Dr. Wright agrees that cause exists for the OBCE to
21 issue civil penalties and costs of this proceeding, and agrees to
22 the imposition of this discipline.

23 6.4 Dr. Wright hereby waives his right to a hearing on any
24 issues presented herein.

1 6.5 Both parties agree to the entry of a Final Order on the
2 following terms which are mutually acceptable and Dr. Wright
3 voluntarily agrees to comply as follows:

4 NOW, THEREFORE, IT IS HEREBY ORDERED:

5 1. That Dr. Wright shall pay the sum of \$200 in civil
6 penalties to the State of Oregon, Board of Chiropractic Examiners,
7 which has already been received.
